Morgan is a 2009 National Champion with the University of Washington softball team where she set or tied 5 offensive records and was named to the All World Series team. Beginning her career as a baseball player, she eventually transitioned into the game of softball where she won the 2004 CIF Division 1 Championship. Morgan earned All-County & All-State honors and obtained a scholarship with the Huskies (2008-2011). Morgan owns Get Defensive, a infield clinic business and travels the country with The Packaged Deal hosting one of a kind softball clinics.

Redmond Town Center and Highway 520: Travel East on Highway 202 (Redmond-Fall City Highway). Turn right at Sahalee Way and travel approximately 4 miles South. Turn left at the intersection of Inglewood Hill Road (NE 8th Street). Travel East .75 miles to the light at 242nd Avenue and turn left into parking lot.

From I-90: Take Exit 15- toward Lake Sammamish State Park. Turn Left onto 17th Ave NW/Renton-Issaquah Road SE. (It becomes NW Sammamish Rd then becomes SE 56th St.) Turn Left onto E Lake Sammamish Pkwy SE. Turn Right onto SE 43rd Way (It becomes 228th Ave SE). Turn right at the intersection of Inglewood Hill Road (NE 8th Street). Travel East .75 miles to the light at 242nd Avenue and turn left into parking lot.
